

JOHNSON COUNTY COMMUNITY FARMERS' MARKET

2022 Rules & Expectations

I. HOURS OF OPERATION

- a. The 2022 Market will run from April 23 to Nov 5.
- b. Saturday times are from 8:00 am to 12:00 pm.
- c. There will be no mid-week Market for the 2022 season. Pop-up markets will be allowed at the front lawn of the Chamber of Commerce (101 N. Johnson) throughout the week.
- d. All sales will begin: Saturdays 8:00 am (with the exception of regular customers picking up preordered items).
- e. The market will be closed or move during largescale downtown events on the court square, such as the Peach Festival.
- f. The public meeting will be held March 31st 5:30 pm at First Security Bank Community Room in Downtown Clarksville.

II. FEES

- a. \$35.00 Seasonal Fee (paid one time, with application)
- b. \$10.00 One Day Pass (must be paid by Friday at 4:00 PM before the market, with application)
- c. Refunds of the Seasonal Fee and One Day Pass will not be allowed.
- d. Vendor spaces shall be decided at the time of application and vendor fee submission using the vendor map. Please respect the space of others.

III. EXPECTATIONS OF GOODS

- a. ALL produce MUST be grown in Arkansas.
- b. ALL artisans MUST create, refinish, or repurpose their items.
- c. Absolutely NO resale or flea market items. NO wholesale. NO exceptions.
- d. NO live animal sales permitted.
- e. A maximum of 20 craft-only vendors will be accepted. Produce, food, and flower vendors will be allowed to sell crafts in addition to their product and will not be considered a craft-only vendor.

IV. RISK MANAGEMENT

- a. Signs are required to identify who vendors are, what they are selling, and prices for items being sold.
- b. To ensure a safe, pleasant environment, all vendors are responsible for the safety and cleanliness of their booths.
- c. The market is not responsible for any accidental injuries occurred at or near the market venue.
- d. Dogs are allowed if on a leash and unaggressive to other dogs or people.
- e. Vendor Card must be displayed at the booth, including the address of product origin.
- f. To encourage safety, please provide a bottle of hand sanitizer for the public at your booth.

V. QUALITY CONTROL

- a. Products offered for sale to consumers must be of the highest quality.
- b. If inferior/or older produce is offered, it must be displayed away from new, fresh products, labeled as such, and sold at a reduced price.
- c. Food Freedom/ Homemade Food Production food vendors are required to display the card, with address at all times, per the Arkansas Food Freedom Act/.
- d. No smoking. No alcoholic beverages.

VI. ENTERTAINMENT & GUESTS

- a. Market rules allow organizations, such as school clubs and related groups, which are complimentary to the mission and goals of the Johnson County Community Farmers' Market, to host a table promoting their group once per year. A one-time use Vendor Fee of \$10.00 is required.
- b. Organizations may sell tickets for their fund-raising efforts based on market manager approval, but no sales of any kind are to occur, outside of ticket sales.
- c. Musical guests, artistic performances, and educational activities may also be allowed with preapproval from the Board or Market Manager.
- d. A one-week pre-approval screening is preferred for all guests.
- e. Businesses and organizations may apply to be a "Market Partner" and/or sponsors by submitting an application to the Chamber of Commerce.
- f. Religious groups and political campaigns are not permitted to operate a booth space (Selling as an individual might be possible as long as guidelines are met. Please contact us to discuss further).

VII. COMPLIANCE

a. Complaints must be delivered in writing to the Market Manager. This will allow the opportunity to resolve an issue before it becomes necessary to involve the full market governing body.

- b. If any vendor is verbally notified on a complaint and continues to violate a rule, they will be sent a written warning of non-compliance. If the non-compliant behavior continues, suspension and/or expulsion may follow.
- c. The Johnson County Community Farmers' Market adheres to the Arkansas Farmers' Market Guidebook, including the Arkansas Homemade Food Production Guidelines, Food Freedom Act, and the "Farmers' Market Vendor Guide," A Guide for Farmers and the Consumer, from the Arkansas Department of Health and the Arkansas Agricultural Department.
